Decree of the President of the Republic of Uzbekistan On Additional Measures to Stimulate Exports and Ensure the Competitiveness of Domestic Goods in Foreign Markets

To further liberalize foreign economic activities and stimulate the increase of exports of products manufactured by enterprises of the Republic:

- 1. Approve the lists:
 - o Items prohibited for import into the Republic of Uzbekistan, in accordance with Appendix No. 2.
- 2. Establish that in the Republic of Uzbekistan:
 - Licensing of goods exports is abolished, except for specific goods stipulated by legislation;
 - Enterprises of all forms of ownership exporting their own products are permitted
 to establish trading houses and representative offices abroad for marketing
 research of foreign markets and promoting their products, with the supply of
 goods on consignment terms, except in cases provided by legislation.
- 3. Introduce amendments to certain acts of the President of the Republic of Uzbekistan in accordance with Appendix No. 3.
- 4. Declare certain acts of the President of the Republic of Uzbekistan null and void in accordance with Appendix No. 4.
- 5. The Ministry of Foreign Trade of the Republic of Uzbekistan, together with the Ministry of Justice of the Republic of Uzbekistan and other relevant ministries and agencies, shall, within one month, submit proposals to the Cabinet of Ministers of the Republic of Uzbekistan on amendments and additions to legislation arising from this Decree.
- 6. Ministries and agencies shall bring their regulatory legal acts into compliance with this Decree.
- 7. Assign responsibility for the implementation of this Decree to the Deputy Prime Minister of the Republic of Uzbekistan Minister of Finance D.A. Kuchkarov, Deputy Prime Minister of the Republic of Uzbekistan Chairman of the Board of JSC "Uzagrotekhsanoatholding" N.S. Otazhonov, and the Minister of Foreign Trade of the Republic of Uzbekistan Zh.A. Khodjaev.
